## WHAT CONSTITUTES RAGGING: -

## Ragging constitutes one or more of any of the following acts:

- 1 .Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in any act that Prevents, Disrupts the Regular Academic Activity.
- 3. Asking any student to do any act which has the effect of causing or generating a sense of shame, embarrassment to adversely affect the physique or psyche of any student.
- 4. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 5. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- 6. Any Act of Physical Abuse causing Assault, Harm or danger to Health, sexual abuse.
- 7. Any Act of injury or infringement of the fundamental right to the human dignity.
- 8. Any Act of abuse by spoken words, emails, SMS or public insult etc.

## Anti-ragging cell

The committee of the Anti-ragging cell includes the anti-ragging committee and anti-ragging squad.

#### A) Anti-ragging committee

- Principal of the institution as Head and with a faculty co-ordinator.
- Executive committee includes department heads, office administrators, PTA members, Police officials, all hostel Wardens, Student representatives, media people and NGO organization.

• The committee is meant for addressing the grievances of students related to ragging issues by receiving their appeals and forwarding them to the head of the anti-ragging cell.

#### B) Anti-Ragging Squad

For the smooth functioning of the anti-ragging squad, staff members are deputed from various departments. They are directed to supervise the activities of the students in the allotted areas to maintain overall discipline on college premises. The deputed staff members have to be alert, monitor all activities of the student groups and report it to the anti-ragging committee if any untoward incidents occur. The chief warden should depute staff members to supervise the activities of students in hostels and should maintain a record of the same in the hostel.

## Organization-wide awareness

- Displaying anti-ragging posters, help line numbers, contact of the responsible authorities at all prime locations including hostels and busses.
- Conducting counselling and anti-ragging awareness for senior students.
- Displaying anti-ragging helpline numbers on the campus.
- Conducting surprise visits to the hostels.
- Receiving the anti-ragging affidavit from the parents and students.
- Separate class timings, intervals, lunch time for fresher and senior students are implemented.
- Separate hostel for the first years.
